



TAX LEVY ORDINANCE

AVON TOWNSHIP

ORDINANCE NO: 2014-11-17T

An ordinance levying taxes for all town purposes for Avon Township, Lake County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of Seven Hundred Twenty Thousand Seven Hundred Forty Six Dollars (\$720,746) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law, for such purposes as:

General Assistance Fund

for the year 2014, collectable in 2015.

SECTION 2: That the amount levied for each object and purposes shall be as follows:

An ordinance levying taxes for all road purposes for Avon Township Road District Lake County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Avon Township Road District on November 18, 2014 does hereby determine and declare that the sum of Nine Hundred Fifty Four Thousand Two Hundred and Eighty Four Dollars (954,284) upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with law, for such purposes as:




