**AVON TOWNSHIP**

**ORDINANCE NO: 2015-12-14T**

An ordinance levying taxes for all town purposes for Avon Township, Lake County, Illinois, for the tax year 2015, collectable in 2016.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of Eight Hundred Seven Thousand Two Hundred Forty Three Dollars (\$807,243.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law, for such purposes as:

General Town Fund

General Assistance Fund

for the year 2015, collectable in 2016.

BE IT ORDAINED by the Board of Trustees of Avon Township, Lake County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Avon Township Road District on November 16, 2015 does hereby determine and declare that the sum of Nine Hundred Fifty Four Thousand Two Hundred and Eighty Four Dollars (954,284) upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with law, for such purposes as:

(35 ILCS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of the Town of Avon (Avon Township), and as the presiding officer, I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check One Of The Choices Below:

1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
