OF ELECTORAL BOARD MEETING

PLEASE TAKE NOTICE that the Township Officers Electoral Board of the Avon Township will hold a meeting of the Township Officers Electoral Board for the hearing and consideration of objections to nomination papers for candidates for Township offices to be voted upon by electors of said Township at the Consolidated Election to be held on April 6, 2021.

The Township Officers Electoral Board shall meet on Tuesday, January 26, 2021 at 6:30 p.m. at the Avon Township office, 433 E. Washington Street, Round Lake Park Village, IL, 60073 for the purpose of hearing said objections to nomination papers. This meeting will be conducted by audio or video conference without a physically present quorum of the Township Officers Electoral Board because the Chairman has determined, pursuant to Section 7(e)(2) of the Open Meetings Act, that an in-person meeting at the Township building with all participants is not practical or prudent because of the disaster. Township officials, electoral board members, legal counsel, and the Township Administrator will not be physically present at the Township administrative offices if that is unfeasible due to the disaster. Physical public attendance at the Township Administrative offices may be limited or not feasible, so alternative arrangements for public access to hear the meeting are available by contacting Township Clerk Jeanne Kearby at 847.546.1446 or jkearby@avonil.us (email) at least two hours before the meeting. In accordance with the Open Meetings Act, the meeting will also be audio or video recorded and made available to the public, as provided by law.
